FINANCIAL HIGHLIGHTS

REVENUE

During the quarter, the cement demand witnessed a decline in growth both in Nigeria and South Africa. Prices in Nigeria increased significantly beginning of September with a full effect anticipated for the Q4. Revenue declined against corresponding period last year following impact of gas shortages, logistics issues in the South East and technical stoppage with the interconnection of the new line in Unicem.

PROFIT AND NET INCOME

Profit for the group was affected by low sales, operational challenges, effect of inflation and naira devaluation on our operating costs. Mfamosing Line II started its operation with first clinker on August 28th and first cement anticipated in November. Ashaka expecting mobilization on site for its power project before year end. The debt restructuring has been completed on July 1st with the conversion of the debt as equity instrument removing volatility on our results.
