FINANCIAL HIGHLIGHTS

REVENUE

First half year 2015 revenues increased by 19% and 12% versus last year, for the Company and Group respectively. Wapco Operations (the Company) had a strong first half year with double digit volume growth, a favorable mix and stable pricing, leading to an overall 19% revenue growth. Ready-Mix grew by 35% in Nigeria, as the Concrete business continues to ramp up. The South Africa revenues were supported by the relative strengthening of the Rand, and grew by 9% on a Naira basis. Ashaka returned to growth in Q2, as the situation in the region stabilized.

PROFIT AND NET INCOME

Overall Net Income for the first 6 months of 2015 grew by 23% versus last year, with Q2 profit improving by 67% versus Q2 2014. The Q2 profit growth was primarily due to continued strong operational performance in the Nigerian businesses with higher coal utilization and lower energy costs in Ashaka and strong top- and bottom-line growth in Wapco Operations.

Unicem had a strong Q2 with an EBITDA of 7.1b Naira and a Net Income of 6.1b Naira. Lafarge Africa's 42.5% share of the Q2 Net Income was 2.6b Naira.
