Introducing our Strategy 2025-'Accelerating Green Growth'

Over the last few years, the construction industry continuously changed due to megatrends such as rapid population growth, changing societal needs, and emerging climate risks and opportunities. In response to these megatrends, the Holcim Group took a bold step in 2018 and launched its Strategy 2022- "Building for Growth".

The Strategy was built around four key drivers: Growth, Significance & Performance; Financial Strength; and Vision & People, all of which had set targets to ensure continuous business growth while delivering resilient returns and longterm value to our stakeholders. Holcim demonstrated excellence by capitalising on our unique company strengths and exceeding our set targets for this strategy a year earlier than expected. This laid a solid foundation for our next chapter of growth, as the Group took the bold and ambitious step of launching the new **Strategy 2025- "Accelerating Green Growth"** in 2021.

We are harnessing the opportunities we have identified to position ourselves as the global leader in innovative and sustainable building solutions, in light of the current global energy transition and the need to adopt greener business practices. With more audacious targets, this strategy aims to increase profitability across the board, with sustainability and innovation at the forefront.

The implementation of Strategy 2025 is being guided by four value drivers, which are as follows:

Accelerating growth:

Driving profitable growth through innovation and green transformation while simultaneously promoting digitalisation across the business. Expanding solutions and products:

Diversifying and integrating business solutions from construction and energy efficiency to repair and refurbishment. Leading in innovation and sustainability:

Developing next generation technologies to remain at the forefront of green building solutions while reducing Delivering superior performance:

Expanding our digital solutions, leading green transformation to our customers, operations with strong profitability and cash flows.

Eight sustainability targets have been established to serve as a guide for monitoring and evaluating our performance across the ESG pillars in order to ensure that the Strategy is carried out effectively. These include;

- Achievement of over 25% of ready-mix sales with 30% to 100% lower CO₂ footprint
- Use of 75 million tonnes of recycled materials and 10 million tonnes of recycled demolition waste and aggregates through circular economy
- Allocating 0.5 billion CHF to green capex
- Reducing freshwater withdrawal by 25% in litres/ton in cement
- Diversifying senior management by increasing the number of women by 40%
- Achieving 520kg Net CO₂/ton of cement
- >40% of financing agreements linked to sustainability goals[Infographics]

These targets have been cascaded down to all our member organisations in order to promote uniformity and ensure timely achievement of the strategy. We at Lafarge Africa Plc are not left behind. CEO's Statement



2021 was unquestionably transformative given the extraordinary circumstances under which we had to operate. Considering the impacts of COVID-19 still being felt, and other macro-economic conditions, we delivered what we promised under our "Strategy 2022 – Building for Growth" as our 2021 performance showed a significant improvement over the previous year.

Our results demonstrated our **focus on innovation**, expanding our collaborative efforts, and our people's unwavering commitment and resilience as we put sustainability at the core of our strategy.

Our achievements in 2021 are a testament to the fortitude demonstrated by our people in the face of global and local disruptions. At Lafarge, we put people at the heart of everything we do, from promoting diversity in our teams to thriving with our communities, and this was evident in our results. We were recognised for our outstanding performance in promoting gender inclusion and diversity within our ranks, in addition to improving gender balance in operational roles.

We achieved a 47% female representation on our board which is a significant increase from 40% in 2020. We also collaborated closely with our communities to foster a more inclusive environment, guided by our Corporate Social Responsibility thematic areas of Education, Economic Empowerment, Health & Safety, and Shelter & Infrastructure.

In 2021, we invested about NGN 2.3 billion in community development initiatives and business inclusive projects, with a focus on youth empowerment, health centre and school construction, road construction, and skill acquisition programmes.

We had our best profit after tax in a decade, owing to improved real estate demand and pricing dynamics as the country focused on infrastructure development across all branches of government. We also kept a close eye on costs as part of our strategy, looking for cost-cutting alternatives in logistics, fuel, and energy. Using waste collected by our

Mr. Khaled el-Dokani Chief Executive Officer Geocycle function in our cement manufacturing process, we saved a total of NGN1.1 billion.

We are extremely proud to be the segment leader in incorporating alternative fuels into our plants and operations, and we remain committed to becoming the global leader in innovative and sustainable building solutions.

Maintaining our commitment to environmental stewardship, we ensured that our activities at Lafarge Africa Plc contributed to our goal of achieving a greener future that benefits people and the planet. In line with our Net-Zero commitment, we changed the power requirements for all our depots and installed solar panels to reduce our carbon footprints.

Our decision to purchase LNG vehicles for our logistics operations helped us save costs on diesel while also improving our environmental performance as LNG emits 30% less CO_2 than fuel oil. Our conversion of the Electrostatic Precipitator (ESP) dust filtration system at Ewekoro Kiln II to the "Bag House" system contributed to the 69% reduction in our specific dust emission from 2020.

In accordance with our Group **Strategy 2025: "Accelerating Green Growth,"** we are poised to become global leaders in innovative and sustainable building solutions. This strategy will enable Lafarge Africa Plc to achieve profitable growth across all our operations, fuelled by sustainability and innovation, by capitalising on current construction megatrends. As we aim to increase our Solutions & Products business to 30% of Group sales, we will implement new technologies in the most appealing segments across the construction value chain.

As evidenced by our performance in 2021, we will continue to be at the forefront of providing green building solutions and will seize the opportunities ahead to drive innovation and create solutions that will accelerate our journey to a greener and more inclusive world.

We used 89,057 tons of waste in our operations in 2021, a 25% ncrease from 2020, at our Ewekoro, Sagamu, and Ashaka co-processing plants, to promote the circular economy.

In 2021, alternative energy sources like waste incinerated ash and used tyres provided 9.4% of our energy.

Lafarge Africa Plc is a member of the Holcim Group with over sixty-three years of experience in providing innovative and sustainable building solutions as a listed and publicly quoted company on the Nigerian Exchange Group (NGX).

We specialise in providing a wide range of building and construction solutions, with a focus on meeting housing and construction needs ranging from small projects such as individual home buildings to large construction and infrastructure projects.

O Our Operations

We have a strong presence in the Nigerian market, with plants in Ewekoro and Sagamu in the South-West, Mfamosing in the South-South, and Ashaka in the North-East. Lafarge Africa currently has a cement production capacity of **10.5MTPA** installed. We have plans to expand our production capacity in the next couple of years. However, in addition to our cement plants, we have twenty-five depots and seven ready-mix sites spread within three (3) out of Nigeria's six geopolitical zones that cater to the production of quality and innovative concrete solutions for small and large construction works.

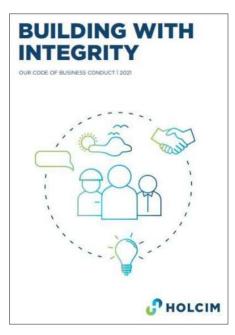

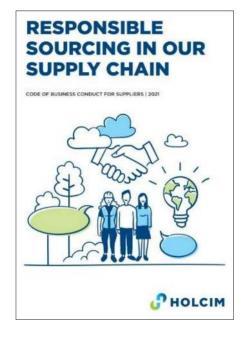
Code of Business Conduct

Lafarge Africa, as a responsible organisation, is committed to corporate transparency and accountability to our stakeholders. To encourage ethical behaviour in our business, we are guided by the Holcim Group's updated code of conduct which reinforces our commitment to operating with integrity and in accordance with relevant local and international laws and global best practices. It expressly states our zero tolerance for violations of applicable laws and anti-corruption regulations, as well as our strict disciplinary measures against violators.

Our Code of Business Conduct ensures that our directors, officers, and employees share Holcim's commitment to ethical business practices. It provides guidance on:

- How to act with integrity in the workplace by promoting health & safety, diversity, fairness, and asset protection;
- How to act with integrity in business by committing to zero tolerance for bribery and corruption, fair competition, and accurate reporting; and
- How to act with integrity in our community by protecting the environment, respecting human rights, and engaging communities.







Holding our suppliers to the same standards as we do, we have our Supplier Code of Conduct that establishes the values and principles that suppliers and other third-party contractors must demonstrate, particularly in the areas of social, human rights, environmental, health, safety, and security standards. These values and principles include:

- Freedom of association and non-retaliation
- Forced Labour and modern slavery

Anti-Bribery and Corruption

Lafarge Africa Plc has a **zero-tolerance policy for bribery and corruption**, and we adopted an anti-bribery and corruption statement, which is embedded in our Code of Business Conduct, communicated within the organisation, to our customers and other stakeholders. To establish our stance against these vices, our values are regularly communicated to all employees through various channels such as trainings, CEO message to all employees, internal communications, townhalls, and one-on-one sessions with relevant teams and key employees. We are committed to:

- Conducting our business dealings and relationships in an ethical manner and with the highest level of integrity, in accordance with the Holcim's Anti-Bribery and Corruption policies.
- Complying with relevant Anti-Bribery and Corruption laws such as Corrupt Practices and other Related Offences Act of 2000 and the UK Bribery Act of 2010 regardless of the business environment we operate in.
- Implementing and enforcing effective systems to counter the risks of bribery and corrupt practices in the form of gifts and entertainment, reciprocal agreements, favours, discounts, travel, education, donations, and other forms of improper benefits for which the Company could be held liable.
- Prohibiting the Company as well as third parties acting on its behalf from engaging in fraudulent acts, corrupt practices and all forms of bribery, gratification, attempting to obtain gratification, facilitation payments, and improper payments or benefits to public officials, their family members, and other individuals.

In 2021, our Management and Non-management employees received training on anti-bribery and corruption. These trainings included Fair Competition and Gift, Hospitality, Entertainment & Travel (GHET).

All our plants (4 cement plants and 6 Ready-mix plants), including our Geocycle operations and Head Offices, have been assessed for corruption risks, with measures established and regularly tracked to ensure that anti-bribery and corruption (ABC), anti-money laundering (AML), and/or sanctions/counter-ter-rorism financing laws are adhered to. In addition, we include anti-bribery and corruption and sanctions clauses in all contracts with suppliers, customers, service providers, and other business partners.



Lafarge Africa Plc adopts a proactive fraud prevention approach, through implementation of effective controls to prevent and detect fraudulent activities and misconduct. Our whistleblowing policy and Global Integrity Platform demonstrates our commitment to integrity, and safe reporting of suspected or actual violations of our Code of Business Conduct in a confidential manner.

Reports can be made anonymously by our employees and stakeholders, the reports are then logged and investigated by our Internal Control & Investigation team.

O Diversity and Inclusion

For us, diversity is more than just a hiring trend; it has evolved into a culture that has been transformed into a strategic obligation. We have reaffirmed our commitment to diversity and inclusion at Lafarge Africa Plc, building on previous initiatives and milestones. We are committed to inclusive workplace practices and therefore we continuously recruit, retain, train, and promote deserving employees from diverse backgrounds and experiences. In 2021, we were recognised at the PWR NGX Top 20 Gender diversity scorecard for our outstanding performance in Board gender inclusion and diversity.

Currently, women hold 47% of the available board seats at the company, a significant increase from 40% in 2020. We value our employees' perspectives and strive for full inclusion across all levels of the organisation. In keeping with the values that the company was founded on; we are focusing our efforts on eliminating systemic prejudice.





We believe that we have a responsibility to our external and internal stakeholders because our stakeholders are critical in how we create positive business impacts.

Therefore, we are committed to continuously engage with our stakeholders in an open, transparent and accountable manner. We are confident that this will enhance a healthy and sustainable long term relationship with our stakeholders."

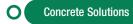

- Development of site concrete quality management systems.





• Value Creation through our Business

At Lafarge Africa, we remain committed to providing shared economic value, as guided by our Group Strategy, and this drives our efforts toward innovation and the creation of sustainable building solutions for the benefit of our stakeholders, communities, and all levels of our value chain.

Despite the disruptions caused by the COVID-19 pandemic, naira devaluation, and worsening economic factors in 2020, **we achieved outstanding results** that set the stage for an outstanding performance in 2021.

We experienced exponential financial growth and exceeded our 2021 targets for achieving the goals of our 2022 Group Strategy across our defined value drivers: Simplification and Performance, Financial Strength, Vision, and People.

The strategic initiatives implemented by our effective leadership demonstrated excellence in resource management and plan execution, resulting in the achievement of our pre-determined KPIs.

As a result, sales revenue **increased by 27.1% to NGN 293 billion**, while earnings before interest and tax (EBIT) **increased by 42.6% to NGN 65.1 billio**n.

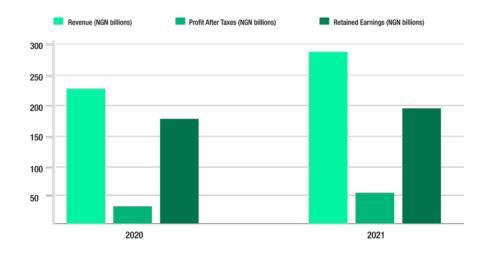

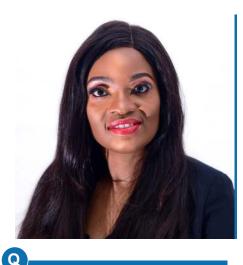

IN 2021 MANY ORGANISATIONS EXPERIENCED TIPPING POINTS. AS THE HEAD OF SUSTAINABLE DEVELOPMENT AND BRAND FOR LAFARGE AFRICA PLC. WHAT WERE YOUR MAJOR HIGHLIGHTS, LEARNING AND REACTIONS TO ALL THESE DURING THE YEAR?

A As an organisation, we accelerated the walk through our mappings in actualising our sustainability ambitions despite the impact of the pandemic. 2021 was a year that demonstrated our continuous resilience and our commitment as an organisation. The decision to forge ahead with our sustainability ambitions despite the impact of a global pandemic was a tall order but despite all the disruptions and setbacks from the pandemic year, using innovation, pragmatism and our drive for excellence at the heart of our interventions, we continued to build on and strengthen our resolve to deliver impact.

The Group Strategy 2025 – Accelerating Green Growth is a key driver in our journey to 'Building Progress for People and Planet' and being the global leader for innovative and sustainable building solutions helped us to chart the course for what we can outline

as our successes today. In the same vein, we set ambitious targets for our strategic sustainability pillars on our path to net zero and continuous positive social impact knowing that sustainability is an ongoing journey.

More highlights from 2021; we co-processed about 89,057 tonnes of waste and these were used as alternative fuels thereby supporting stakeholders' goals of achieving a cleaner and safer environment, this was achieved in partnership with Geocycle, the waste recycling arm of Lafarge Africa Plc Through innovation and continuous improvement, Lafarge Africa Plc also launched over 50 Liquefied Natural gas (LNG) trucks to drive sustainable supply chain targets. This ongoing intervention aims to improve environmental performance as LNG generates 30% less carbon dioxide than fuel oil and 20% less than diesel.

We invested over NGN 2bn in corporate social responsibility and business inclusive projects, enabling positive social impact in host communities and beyond. Our gender diversity initiatives are recording a significant improvement. Lafarge Africa Plc was recognised in the Top 20 gender diversity scorecard for listed companies in 2021. Our success spoke for itself as we also received awards such as the: Corporate Governance Award by the Institute of Directors, Recycling Company of the Year by the Africa Clean Up Initiative and most consistent brand in Sustainability by the Brand Communicator. Our collaborative efforts as a team driven by sustainable development propelled us through the journey.

Through it all, some performance indicators such as Health & Safety, CO₂ emissions reduction and environmental sustainability, 100% CSR completion rate, as well as impact monitoring and evaluation remain a constant barometer in our Sustainability journey.

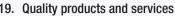

• Our Net-Zero Commitment

As global climate action gains momentum, businesses are setting ambitious targets to decarbonise their operations.

The race to net zero will forever change the way in which many companies do business but we at Holcim are ahead of the curve being the first global building materials company to sign the UNGC's "Business Ambition for 1.5°C initiative", with 2050 targets validated by SBTi.



We have set ourselves ambitious targets short- and long-term targets validated by SBTi to accelerate our reduction in CO₂ intensity.

We will maximise the deployment of existing technologies and will start laying the groundwork for our net zero journey to 2050. We are committed to;

- Reduce our scope 1 and 2 GHG emissions by 95% per ton of cementitious materials by 2050 from a 2018 base year;
- Reduce our absolute scope 3 GHG emissions by 90% by 2050 from a 2020 base year.



In line with our Group's strategic direction, we are approaching net zero in a holistic manner, from automation and artificial intelligence to accelerating green solutions such as increasing the use of alternative materials in our clinker production.

We will accelerate our efforts to achieving net-zero emissions that benefit both people and the environment, in accordance with our Group's Net-Zero commitment.

We have set country-specific targets across all our pillars that are continuously monitored, guided by our strategy, which focuses on four thematic areas: **Climate & Energy, Circular Economy, Nature, and People.**





According to the GCCA, with the world's population expected to reach nearly 10 billion people by 2050, urbanisation has the potential to increase by 68%.

Over the next several decades, these increases will fuel a critical demand for infrastructure, particularly in Nigeria.

As such, we actively manage climate change challenges and take responsibility for our direct and induced carbon emissions as a company committed

CO2 Emissions (SDGs 7, 11, 12, 13)

According to the Global Alliance for Building and Construction, the harvesting, manufacturing, and transportation of raw materials used in building construction now accounts for 11% of global emissions.

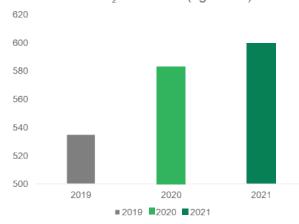
Therefore, we at Lafarge ensure that we employ sustainable and innovative solutions to decrease our carbon emission levels throughout our extraction, processing, manufacturing, transportation, and distribution processes.

to a green and sustainable future, demonstrating our commitment to building resilience against the negative effects of climate change.

In accordance with our Group's net zero commitment, we have set realistic targets for ourselves to ensure that we are not only energy efficient and cost effective, but also contribute to lowering carbon emissions levels in accordance with the Paris Agreement on Climate Change.

Using cutting-edge technologies, we have remained steadfast in our journey towards achieving the targets mapped out in our Group's ambitions to produce 40% less net CO_2 per tonne of cement and 520Kg net CO_2 / tonne of cementitious material by 2022.

The specific CO_2 emmission - net (kg/tonne cementitious material) emitted in LAP plants in Nigeria was 598kg/tonne in 2021 compared to 583kg/tonne in 2020. (A)

Following the assessment of our operations to identify the major sources of $\rm CO_2$ emissions in 2020, we implemented $\rm CO_2$ emission reduction initiatives in 2021 to reduce our current output.

They are as follows:

- Reduction of the clinker content used in our cement production
- Reduction of fossil fuel consumption by increasing the use of industrial waste and biomass
- Implementation of our save power strategies to ensure reduction of power consumption in producing cement
- Reduction of non-kiln fuels by reducing materials transport and handling by mobile equipment
- Maintenance of mobile equipment at intervals of 250 hours



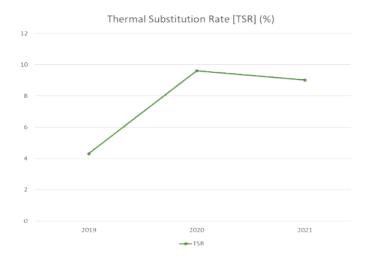
Energy Consumption & Efficiency (SDGs 7, 11, 12, 13)

Operating in an energy-intensive industry with significant environmental, health, and safety implications, we have a longstanding commitment to reducing the environmental impact of our operations to the bare minimum using energy efficient technologies.

Lafarge Africa places a high value on the use of non-fossil fuels in our plants.

As an alternative fuel, we use mixed industrial waste, agricultural waste, tyre chips, and biomass to power our kiln.

In 2021, we achieved a global substitution rate of about 9.4% compared to 9.3% recorded in 2020.



We were able to achieve this substitution rate due to a good number of initiatives that were implemented throughout the course of the year.

At our Ewekoro plant, we reached an agreement with our Operations and Maintenance (0&M) operator to reduce the number of engines run at a time

to improve effective usage of all the engines, thus improving our effective utilisation.

In addition to these initiatives, our 10 golden rules have been a constant driver for monitoring our heat consumption reduction at all our plants. They are:

- 1. Optimise Ball Mill Power: Ensure that the ball mill performances are optimised in terms of production and/or specific power consumption through regular inspections and audits, proper internals condition and operating parameters monitoring.
- 2. Minimise False Air: Ensure through regular inspections, repairs and monitoring that we only handle the minimum gas flow required by the process and minimise air in-leakage.
- 3. Manage Equipment Idling: Ensure that any power consuming equipment not required to run has been shut down, that the start/stop sequences have been challenged and the number of start-ups minimised.
- Optimise Mill Power: Ensure that the vertical mill performances have been optimised in terms of output and specific power consumption through proper maintenance and monitoring.
- 5. Handle Gas Efficiently: Ensure that the minimum gas flow required for production is handled efficiently with minimum pressure drop through proper inspection, maintenance and operation.
- 6. Monitor Power Consumption: Ensure that power meters are installed and operated in such a way as to allow an accurate and reliable tracking of our consumption per shop. It will allow us to check our power bill and to take advantage of the lowest tariffs, revenues from curtailments and savings from low balancing costs due to precise load forecasts.

- Manage Production: Ensure that we will deliver a daily/ weekly/ monthly production planning to be able to predict our power consumption accurately and optimise our power costs
- 8. Master Clinker and Cement Quality to lower Power Consumption: Ensure that we will produce a reactive and uniform clinker, which will allow us to meet the Lafarge Quality Technical Specifications without excessive grinding
- 9. Control Mill Feed Size: Ensure that we select and operate the size reduction process in the most effective way, by setting targets for feed size, by performing regular inspections and monitoring performances
- 10. Minimise Compressed Air: Ensure that the quality and quantity of compressed air is delivered according to usages, distribution is optimised and leaks are corrected. The amount of compressed air used has been minimised

Climate Change Risks (SDGs 7, 8, 13, 17)

The building materials sector is one of the most vulnerable to long-term climate risks because of its significant contributions to global carbon emissions and the high cost of decarbonisation technologies.

To meet the climate targets, major changes in production methods have been made over the years through operational advances and technological innovations to ensure that production demands are met while remaining cost effective.

Climate action is pivotal to Lafarge's strategy as we strive for a net-zero built environment. By driving circular construction to reduce, reuse and recycle materials wherever we can and promoting environmental stewardship, we are contributing to the decarbonisation agenda.

We are guided by our Group's 2030 targets of:

- Scope 1: Net CO₂ of 475Kg/tonne of cementitious material
- Scope 2: CO₂ of 13Kg/tonne of cementitious material

In addition to the CO₂ reduction initiatives implemented in 2021, we planted about **16,500 trees** as part of our quarry rehabilitation plans.

Tree planting does not only support biodiversity but also acts as a carbon sink as it absorbs carbon dioxide (CO_2) and other pollutant gases from the atmosphere thereby contributing to cleaner air and climate change mitigation.

We also minimised the use of imported coal in our operations and rely solely on locally sourced coal. Furthermore, in 2021, we used 6% less coal in our energy consumption than we did in 2020.

Energy Transition Risks (SDGs 7, 11, 12, 13, 17)

As the demand for building materials rises in response to increased infrastructure development and population growth, it is critical that we meet these demands while also supporting the low-carbon economy.

As part of our "Green Logistics" initiative, we launched a new set of 52 Liquefied Natural Gas (LNG) fuelled trucks, in accordance with the current global energy transition to net zero. As a result, reducing our carbon footprint in terms of transporting and utilising coal while helping to boost the local economies.

With increasing pressure on our industry to reduce its climate and environmental impact, our long-term emission-reduction targets will allow us to meet regulatory requirements and achieve net-zero emissions by 2050.

It is an excellent alternative to be adopted in **reducing greenhouse gas emissions** and aiding in the fight against global warming, thus reaffirming our commitment to achieving our net zero carbon emission ambition while protecting the environment in collaboration with Ecologique.









Recognising that we are major players in an energy-intensive industry, we have implemented innovative technologies to become more energy efficient and **reduce our carbon footprint**.

Twenty-two (22) of our depots and distribution centres, as well as our Cement plants and offices were running primarily on fossil fuel driven generators.

We conducted solar studies and successfully transitioned 90% of our power from the national grid and AGO generators to solar panels across all our depot locations in 2021.

We deployed **79 solar streetlights** and **30 solar panels** which now power our offices and IT facilities.

For our cement plant at Ewekoro which will have a higher energy demand due to the cement plant being built, the use of solar generated power is to be integrated at the low voltage side.

Upon completion, this factory will operate 24/7 with an average power demand of 3MW and an estimated average annual consumption of 26GWh.

As such, Lafarge Africa has made plans to adopt an energy mix that will include both gas powered and solar powered engines.

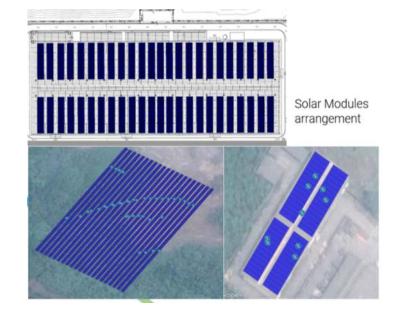

Additionally, we have completed solar studies for our Head Office (500KW), Sagamu plant (1.3MW), all of which are currently awaiting approval, with plans to begin studies for our Ashaka plant in 2022.

Lafarge Africa has also made plans to gradually reduce our reliance on gas at our Mfamosing plant. The reductions in the first phase (25%) and second phase (50%) are contingent on a successful negotiation with our gas providers.

Furthermore, and in alignment with our strategy, we have received approval from our management to sell excess power capacity to the national grid, allowing us to run our engines more frequently due to an increase in offtakes. As a result, our energy efficiency improves because no energy is wasted.

We are committed to improving our operational efficiency as we work towards our **Strategy 2025- Accelerating Green Growth.**

Lafarge Africa intends to increase CAPEX to improve waste recovery systems and retrofit our plants with improved metering and monitoring systems to keep track of our emissions and energy consumption.





• Circularity for a Net-Zero Future

At Lafarge Africa, we have developed a business strategy that will replace the linear concept of production with a circular economy model.

Our Geocycle function is a leading provider of industrial, agricultural, and municipal waste management services allowing us to reuse, optimise, and recycle waste and reduce our reliance on non-renewable raw materials.

As a Group, our goal is to **recycle 75 million tons by 2025,** with 10 million tons of construction and demolition waste (CDW) converted into new, high-value products.

We intend to accomplish this by utilising innovative technologies to maximise our resources for the benefit of our company, society, and the environment.

Resource Efficiency (SDGs 6,8,9,12,14,15)

Underpinned by our commitment to developing more innovative and sustainable solutions, we aim to manufacture more products with fewer new extractive materials for the construction of longer lasting and more resilient structures.

As a result, we are continuously conducting research to identify new ways of reducing our new materials and incorporating pre-processed waste materials into our manufacturing process. In 2021, our waste management service for a major oil and gas company took off with the successful sustainable and controlled co-processing of waste incinerated ashes generated from the oil fields.

Our existing collaborations with well-known pharmaceutical companies, used tyre pyrolysis companies and some notable FMCG group in Nigeria forged on as they committed their waste management to Geocycle.



We are committed to building more with less to enable greener cities, smarter infrastructure, and improved living standards as we drive circular construction across our business to minimise waste and preserve nature's resources.

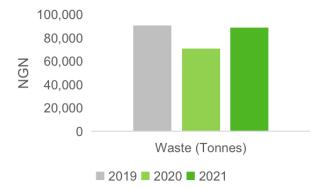
In 2021, Lafarge Africa utilised 89,057 tons of waste, compared to 71,029 tons in 2020, representing a 25% increase. (A)

This volume of waste derived materials is equivalent to 9.4% of our thermal energy across the country.

Following successful planned upgrades, our two kilns at the Ewekoro plant are fully equipped with co-processing and pre-processing facilities that will facilitate our journey toward net zero target of achieving 20% reduction in CO₂ intensity by 2030 (compared to 2018 baseline).

We affirm our commitment to decarbonising all our operational sites by co-processing of waste materials.

Furthermore, to reduce our reliance on natural gypsum and iron ore, we made use of synthetic gypsum and iron mill scale wastes from other industries as raw materials and cement additive materials.

The successful completion of the upgrading of our dust collection system at our cement plants also improved the reuse of collected dust in clinker production.

Thus, reinforcing our obligation to use our resources in a closed loop system to reduce waste and protect the health of our people.

In order to meet the Paris Agreement's goal of reducing direct CO2 emissions from cement and concrete production by 24% by 2050, we are developing methods to replace clinker with low-carbon alternatives and increase the use of alternative fuels in our kilns.

We prioritise thriving with our people and promoting shared growth at Lafarge Africa.

Our circular economy model enables us to build a waste-free, economically viable, and socially inclusive society. This innovation has immensely benefited our host communities due to more job opportunities created and improved livelihoods. Our conservation of natural resources is hinged on long-term sustainability. This has enhanced our capability to assist other businesses by incorporating by-products such as synthetic gypsum and iron mill scale from steel mills into raw material additives.

Through the value chain of our biomass alternative fuel sourced from various communities in the South West and South / South of Nigeria, we generated more than 3,000 jobs in 2021. This includes value chain support offered by our direct host companies.

2021 Geocycle week: Think Planet, Think Solutions

Taking pride in being leaders in innovative and sustainable building solutions, our Geocycle function celebrated its 2021 Geocycle week, which was themed "Think Planet, Think Solutions." This celebration coincided with World Clean-up Day.

In partnership with the Food and Beverage Recycling Alliance (FBRA) and our employee volunteers, we commemorated the day with a cleaning exercise at the popular Bariga market in Lagos.

With Lagos, Nigeria's bustling city of nearly 16 million people, generating approximately 13,000 and 15,000 tonnes of waste per day, it was critical to educate people in our community on the importance of sorting waste at the source and cleaning up the environment.

We cannot overemphasise the need to reduce the amount of waste that ends up in dumpsites and drainage systems, as well as to prevent poor waste management.

The World Clean-up Day served as a reminder that we all have a role to play in achieving a zero-waste future.

Mr. Daniel Adedokun, our Head of Geocycle, attended and expressed Lafarge Africa's commitment to plastic neutrality, stating that over the years, we have collaborated with industries to drive innovative and sustainable solutions through our use of plastic waste in energy generation.

Lafarge Africa aims to meet our global commitment by investing continuously in waste pre-processing and co-processing. These investments are steadily allowing us to shift away from carbon-emitting energy sources and toward renewable energy sources to power our plants.

We will continue to push this forward through individual efforts and collaborations with other organisations and communities to ensure progress for people and the planet, as well as a greener, more sustainable environment.



O Packaging (SDGs 7, 12)

As the world prioritises addressing the issue of packaging waste, we must design environmentally responsible and highly protective solutions for our products.

Lafarge Africa places a high value on our ability to reduce our environmental impacts wherever possible. As a result, we leverage our strong research and development capabilities as well as local market knowledge to develop innovative greener packaging solutions.

We remain committed to using sustainable cement packaging solutions to preserve our products when in storage. In addition, we will curtail waste of resources due to a lesser need to replace products thereby reducing our $\rm CO_2$ footprint.

In 2021, we began the construction of our cement bag manufacturing factory at Ewekoro plant. We intend to run this plant on a hybrid energy mix, incorporating approximately 2.5MW of solar energy.

By adopting this vertical integration approach, we are not only cutting costs through economies of scale, but we are able to have control over the quality and sustainability of product packaging.

Product Innovation (SDGs 8,9,11,12,13)

As a business focused on delivering sustainable and innovative building solutions, we are constantly on the lookout for new and efficient ways to reduce our reliance on natural resources and fulfil our commitments to a zero-waste future.

We aim to remain at the forefront of sustainability initiatives in the cement industry by utilising our existing assets with additional CAPEX to provide waste management solutions.

Consequently, we are making a significant contribution to achieving the ambitious sustainability targets by reducing greenhouse gas emissions and providing zero waste solutions for other industries. Recently, we evolved a cement production strategy in one of our major plants and this migration will lead to a reduction in embedded CO_{2} in the products.

In collaboration with our Switzerland Technology Centre and over 210 researchers at our industry-leading Research and Development Centre in Lyon, France, we continue to identify local alternative materials that can be co-processed and used as a component of our cement.

We will continue to develop new strategic partnerships in this manner to enable us to increase the availability of renewable waste materials in accordance with our circular economy model.

Currently, ongoing discussions are underway with various third parties for investment in Pyrolysis plant using waste used tyres as feedstock in the Northeast region for the country.

This will boost our Ashaka Plant alternative fuel resource use with a ramp up target of 50% fuel substitution. We intend to install a carbon black handling and rice husk feeding system at the plant in order to achieve the target thermal substitution rate.

Innovation for Water and Biodiversity Conservation

We rely heavily on natural resources for our manufacturing processes due to the nature of our industry.

As a result, we prioritise nature by ensuring that our activities have a low environmental impact and that we offset any unavoidable impacts as much as possible.

Environmental Compliance (SDGs 2,3,12,13,15)

We take pride in being a responsible organisation, and as such, we constantly ensure that all relevant environmental laws, regulations, and standards applicable to our operations and products are adhered to. Guided by our approved environmental policy, it enables us to put in place effective and efficient safeguards to reduce the negative externalities of our operational footprints.

We have twelve (12) approved Environmental and Social Impact Assessment (ESIA) for all our sites obtained from the Federal Ministry of Environment prior to the start of our operations, demonstrating our leadership in environmental stewardship and role-modelling responsibility for future generations. Our monitoring phase for impact mitigation was also completed successfully.

Furthermore, we ensure that all our plants and quarries undergo a statutory Environmental Audit every three years. In the event of project expansion, we developed an Environmental Management Plan (EMP) and ensure approval

Air Emissions (SDGs 3,9,15)

Dust is a significant component of our emissions as it is emitted during various processes such as handling raw materials, through our cement mills and kiln stacks, leakages from the conveyors and vehicular traffic within the factory. We recognise that this poses a significant risk to the environment and the health of our people.

As a result, as part of our plans for environmental stewardship, we have dust control equipment installed across our process lines to minimise the impact and we have installed on-line monitoring equipment in our plant to ensure real-time monitoring and measurement of our dust emissions across our plants. This is evidenced by the methods we have developed for biodiversity and quarry rehabilitation, effluent and waste management, water contamination reduction, environmental compliance, and eco-friendly production.

This aligns with our Group's environmental and biodiversity directives of conserving and restoring the natural resources on which we rely.

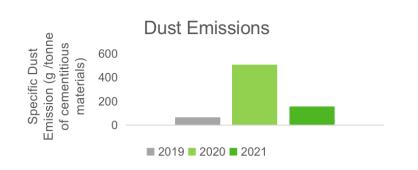
In 2021, we recorded a 100% ISO 14001 Environmental Management System certification for all our cement plants. (A)

Staying committed to reducing air pollution and water management, quarterly emission monitoring exercises are conducted by government approved consultants regularly and reported to both state and federal regulators. The parameters monitored are air emissions (dust, NOx, SOx) and water discharges (PH, TSS, temperature difference). We also ensure that elemental analysis of water samples is also done according to the regulation in all our plants.

In 2021, we had zero non-compliance cases reported and no environmental fine for the year.

This is calibrated on a regular basis to ensure dependability, and it is also tracked for internal monitoring and assessments, as well as external examination by environmental regulators.

Following a significant increase in dust emission in 2020 to 541.82 g/tonnes of cementitious material, we upgraded the Electrostatic Precipitator (ESP) at our Ewekoro Plant 1 to a more modern system of a "Bag House " dust collection system in 2021. This significantly reduced our dust emissions to 156 g/tonnes of cementitious material in 2021, a **69% reduction** from the previous year, which is below the Nigerian regulatory limit.



As part of our responsibility to Holcim group's environmental and biodiversity directive, we have installed on-line monitoring equipment in our plants to measure our dust emission on a continuous basis. This equipment is also calibrated at regular schedules, to ensure good reliability.

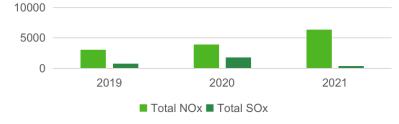
We also ensure a minimum stock reorder level of dust control equipment spares are also put in place to respond to failures and conduct preventive maintenance as needed to reduce dust emissions from other sources, such as dirt roads surrounding our plants.

We conduct quarterly air quality monitoring within a 10-kilometre radius of

our facilities to ensure that it is within acceptable limits with reports submitted to National Environmental Standards and Regulations Enforcement Agency (NESREA).

Additionally, in accordance with the Group's standards and local regulations we monitor and manage other types of air emissions monitored and managed.

Biodiversity and Quarry Rehabilitation (SDGs 1,2,3,8,9,12,14,15)

As issued under Holcim's Environmental Policy, we have an obligation to Biodiversity and Quarry rehabilitation which governs our operations within our quarry sites. As a result, the biodiversity survey conducted acts as a baseline in all our sites, from which we developed our Environmental Management Plans.

We have 100% of our quarries with approved rehabilitation plans in place which act as a guide in ensuring that all our operations are carried out responsibly and efficiently, minimising any risk our operations may pose in maintaining the ecosystem while considering the ecological complexes. None of our operational activities were in protected or identified high biodiversity areas as of 2021.

Following the mine restoration studies completed by Golders Associates (SA) in 2018 for all our quarries, we conduct progressive quarry rehabilitation on an annual basis.

Our Environmental Protection and Rehabilitation programme has been approved by the Ministry of Mines and Steels Development and which details the actions and steps we have in place for rehabilitation of our mined areas. Our rehabilitation programmes, common to all our plants, are aimed at promoting favourable microclimatic conditions for inhabitants and minimising soil erosion, run-offs as well as contributing to biodiversity. To sustain biodiversity, the statutory environmental audits and regular joint inspections conducted by relevant stakeholders from the Ministry of Mines and Ministry of Environment inform our reports which are submitted to both state and federal regulators.

The incorporation of our quarry site rehabilitation plan into our yearly extraction/mining plan has assisted us in rehabilitating approximately 933 hectares (ha) of land as of 2020. In 2021, 600 hectares (ha) of land within our quarries was rehabilitated, reinforcing our commitment to driving the creation of carbon sinks and afforestation.

We constantly engage with our host community in the selection of vegetation to be planted to ensure that our choice provides both ornamental and economic benefits to them. In 2021, approximately 16,500 seedlings were planted in and around our quarries across the country, with over 50,000 young trees properly maintained.

We began our five-year Maiganga Wetland Project, which aims to improve acid mine drainage and establish a biodiversity hotspot in an arid area, as part of our commitment to reinventing the way we build a greener and healthier future for all.

Following approval from the Federal Ministry of Environment and community support, the wetland system was developed in the vicinity of Maiganga, Kargo-Burodi, Kayelbaga, Tudun-kuka, Kalkulum, Lakwalak, Kubwan-tangale, Kubwan-fulani, Kargo-maishanu, Piyau, Komta, Alatai, Kuibah, and Kulapandi communities in Akko and Billiri Local Government Areas of Gombe State. Wetlands not only provide habitat for a diverse range of aquatic and terrestrial animals and plants, but they also play an important role in water storage and

Effluents and Waste (SDGs 3,8,10,12,13,14,15)

The cement manufacturing industry contributes significantly to global waste generation. Given the current megatrends influencing our industry, it is critical for us as a company to manage and reduce the waste we generate. Thus, the National Environmental (waste sanitation) Regulations serve as the foundation for our waste management procedure, which guides operations across our plants. Our EMS ISO-14001 certifications cover waste management from cradle to grave, with state environmental protection agencies saddled with the responsibilities of waste evacuation and disposal across plants to the government approved dump sites.

We have segregated scrap yards where scraps are temporarily stored prior to disposal or purchase by state accredited scrap buyers to ease our waste sorting process. Medical waste from our clinics is also either temporarily disposed of in designated biohazard bins prior to collection by government-approved agents or incinerated in our plant clinics. treatment by relying on natural dynamics to achieve purification.

As of 2021, construction works on the system, including pump installations and testing had been completed and afforestation with over 70,000 plants, including economic crops such as mangoes, cashew, etc, on 6 hectares of land.

This project aims to not just improve water quality but also benefit over 2,000 residents of Maiganga and the microclimate of the surrounding communities in the long run as it contributes to our Group's target of **reducing our carbon footprint by 2030**.

When there is a need to dispose of radioactive sources, the foreign manufacturer removes them following approval from the relevant authority.

At some of our plant locations, our effluents are treated in chlorine tanks in sewage treatment plants. In accordance with regulatory requirements, we also conduct continuous sampling of run-offs and effluent water in-house by a government-accredited third-party consultant. COD and other physicochemical parameters are considered in this sampling analysis.

As part of our manufacturing process, we produce hazardous and non-hazardous waste.

The table below shows the type of waste by amount disposed in 2021 in comparison to 2020 and 2019 figures.

Water Contamination (SDGs 3,6,12)

At Lafarge Africa Plc, we are obligated to ensure that our quarry and plant operations have minimal negative impact on the quality of water within our host communities, which is in alignment with Holcim's environmental targets.

Thus, we have set up management initiatives in place to include:

- Continuous awareness and trainings on water conservation across the country.
- Periodic checks/inspections conducted along the water lines for leakages by the utility team.
- Installation of emergency response procedure available for management of water leaks, with periodical test for effectiveness.
- Installation of water flow metres for monitoring of water usage.

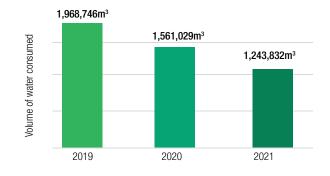

We do not depend on any municipal water supply, as water is efficiently utilised in the process of cement manufacturing, using a closed-circuit system where we utilise only what we require. The source of our water is natural from ponds created to contain dewatering activities from the quarry and rainwater.

In 2021, Lafarge Africa recycled a total of 446,507.69m³ of water across Ewekoro, Mfamosing and Ashaka plants, while consuming in total 1,243,832.46m³ of water, which is 5.5% reduction from 2020.

Our specific freshwater withdrawal was 157.71 L/ton of cement in 2021. (A) We also recorded a specific freshwater withdrawal for ready mix of 204.42 L/M³.

We also recorded a total of 182,985.36m³ for water credits from water access and sanitation to our communities for the year 2021.

Over time, the use of these materials has resulted in the destruction of trees and environmental degradation due to mining. Lafarge Africa, as an organisation dedicated to creating a better and more sustainable world, has taken steps to optimise the use of available alternative materials and energy sources, which is critical to achieving a carbon-negative manufacturing process.

In response to this, we are putting our innovation to work to make sustainable building possible, with solutions ranging from low-carbon materials to more efficient water systems that do not compromise our performance.

In line with our strategy, we have a continuous commitment towards resource recovery that contributes to the reduction in our $\rm CO_2$ emissions and biodiversity stewardship.

Rather than sourcing, mining, and milling new components for our building material, we substitute using recycled plastic and other ground-up waste to produce concrete. Our Geocycle operations provide us with alternative materials to be used in our manufacturing process such as plastic and agricultural waste, construction and demolition waste, and recycled steel.

By implementing this practice, we are reducing our greenhouse gas emissions and giving non-biodegradable waste new use, rather than clogging landfills and contributing to plastic pollution.

Economic Value (SDGs 2,3,8,9,10,11)

As an organisation committed to the creation of shared value for all, we contribute towards the economic growth of the country through our commercial and industrial operations.

We ensure that our financial performance is disclosed in accordance with standard accounting principles, in compliance with all the government-mandated financial regulations.

Our approach for generating economic value is aimed at building sustainable cities that contribute not only to Nigeria's building and infrastructure industry, but also to the country's Gross Domestic Product (GDP). In 2021, our revenue generated from cement and construction materials was NGN 293 billion, with capital expenditure (asset depreciation) accounting for 27% of value added, wages and salaries accounting for 22%, and finance costs and taxes accounting for 3%.

Our Geocycle function served as an avenue to create approximately 3,000 jobs in our host communities through our biomass project. From 1,748 suppliers in 2020 to 1,816 suppliers in 2021, our supplier base increased by about 6%.

To ensure that this value creation is widespread, we use our local suppliers interchangeably and encourage them to hire people who can deliver within communities. This demonstrates our dedication to promoting local content development.

Following strong demand in the cement sector, Lafarge Africa Plc paid NGN 2.7 billion in corporate income tax and created over **1,000 direct and**

indirect jobs across our entire value chain, positively impacting the Nigerian economy.

We believe that knowledge transfer is an efficient method for a business to generate long-term economic value; thus, we are better equipping the nation's workforce and contributing to economic growth through our training programmes such as the Cement Manufacturing Technical Workshop, the Process & Production Engineering Development Program (PPEDP), and the Preventive Maintenance Engineering Development Program (PMEDP).

Cybersecurity is an integral aspect of our company's ability to withstand business disruptions.

We recognise the vital role that information technology plays in driving company success, and as a result, we have structured our systems and processes accordingly.

In 2021, we improved upon the foundation laid during the COVID-19 pandemic in the previous year. During the reporting period, we took extra precautions to ensure that our IT security and governance policies and processes were adhered to. Our Disaster Recovery Plan, which includes potential IT risks and mitigation measures guided our activities during the year. We were intentional about communicating our cyber security and data protection processes to employees, contractors, customers and other stakeholders who might be involved in or affected by its implementation.

resulted in the development of a strategy based on a cost analysis of the costs incurred to serve various markets over time.

We are fully committed to adhering to the Nigerian Data Protection Regulations (NDPR), in 2021, Lafarge Africa Plc was listed as one of the entities that prioritised data protection requirements. Lafarge obtained the National Information Technology Development Agency's (NITDA) approval to place the NDPR Audit Compliant Mark on its's website as a compliance testament.





O Business Resilience (SDGS 8,9,11,12,16,17)

We have taken steps to improve our ability to anticipate and prepare for change, as well as adapt to events in ways that maximise long-term value. We have been able to expand our supplier network, conduct safety audits, develop training programmes and information technology systems, and implement mitigating measures due to these steps.

We maintained oversight of our business operations in 2021 through the operations of the Business Resilience Team (BRT) and our Health, Cost, and Cash Action Plan, which was implemented in 2020.

The BRT was tasked with the following responsibilities in response to changing business environments caused by external events:

- The designing, planning, and testing of company responses to likely disruptions and situations occurring within and outside of the organisation
- Updating the country's Trigger Action Response Plan (TARP) and implementing agreed action plans whilst updating the group on progress and results
- Equipping the organisation in adapting to the new normal whilst simultaneously safeguarding the safety of our people, operations, and results.

These responsibilities were adequately carried out during the reporting period and business processes ran smoothly as a result.

Foreign exchange factors (SDGS 8,9,11,12,17)

Despite the continuing inflationary and currency-exchange effects of the COVID-19 pandemic in 2021, our strategy for creating economic value remained centred on developing sustainable cities that contribute not only to Nigeria's construction and infrastructure industry, but also to the country's gross domestic product. Our cement and construction products generated **NGN 293 billion in direct economic value**,with 35% of this value added retained for maintenance and replacement of capital investment in 2021.

As the naira depreciated and foreign exchange rates fluctuated, we maintained strategic and effective engagements with our stakeholders, resulting in minimal disruptions to our operations.

To mitigate against fluctuations in foreign exchange, we localised our imports by expanding our local supplier base by 3%.

We also reduced our gas-related energy costs, which are tied to employment transactions using alternative fuel (shredded tyres, palm kernel shells, sawdust, industrial waste, carbon black, and shredded plastic) at our Ewekoro, Sagamu, and Ashaka facilities.

We also discontinued the use of imported coal in our kiln, utilising more locally mined coal.

As part of our compliance training plan, new hires and relevant teams received fair competition and other compliance training in 2021.

Our Health and Safety measures extend to our drivers and other external parties as well. In 2021, we implemented the following four approaches to safeguard the health and safety of our contracted drivers and other parties:

- Organisation of driver training and coaching programs: Included in this category are Aegide DDT, Motorbike Incident Prevention, and Roll-over Incident Prevention. These three trainings provide a total of 16 training hours each year for each driver.
- **Monitoring the performance of drivers:** In-Vehicle Monitoring System (IVMS) installation on all of our specialised vehicles, enforcement of driver tags (identifying means) for all drivers, daily monitoring and review of drivers' performance, including Hours of Service (fatigue)
- Management of the performance of drivers: This pertains to our administration of consequences and rewards. This includes the daily application of consequences to all high-risk drivers in our operations and the quarterly delivery of incentives to the country's top 30 safest drivers and top 3 safest transporters.
- Community road safety awareness: A road safety awareness campaign was conducted in the communities where our plants are located, including Sagamu, Ewekoro, Mfamosing, and Ashaka. This awareness involves the dissemination of road safety education, the distribution of reflective vests to community schools, and the distribution of crash helmets to commercial bike riders. The campaigns are conducted in partnership with state traffic regulating organisations.



Employee and Labour Relations (SDGS 8,11,17)

Lafarge Africa Plc is in alignment with the national government regulations, the International Labour Organisation (ILO), and the United Nations Global Compact (UNGC) regarding the management of employee labour relations. We are dedicated to promoting an environment in which the individual rights, freedom of association and right to engage in collective bargaining of our employees are acknowledged and protected.

We have created processes, such as the "Integrity line," that allow our employees to file complaints involving human rights violations, harassment, and discrimination, among other concerns. Existing collective bargaining agreements require a minimum notice period of three (3) months for any significant operational changes, including but not limited to restructuring, outsourcing, and closure of our activities.

With "Health and Safety" being the overarching core value of Lafarge Africa, it illustrates the importance we place on this aspect of our business. We reaffirm our commitment to doing our business in a manner that supports a safe and clean environment for all of our stakeholders, including our employees, our vendors, our customers, and our communities. Our purpose is to not harm the persons with whom we engage, and the success of this goal depends on the contribution of every employee.

Using our management systems, we ensure that every one of our employees is aware of the contribution they make to the success of our business. Our objective is to create a culture that promotes individual responsibility and accountability for health and safety and to do so in a manner that is conducive to a safe working environment for both our employees and the contractors we work with.

Our company's success is dependent on our employees' ability to support the achievement of our organisational goals, as they are our most valuable resource. Lafarge Africa prioritised employee health and well-being due to the mental health challenges posed by the pandemic, as well as adjusting to new work methods. As a result, we remained committed to fostering an environment that promotes both personal development and well-being.

We continued to use the technologies deployed to reduce work-related disruptions, guided by our flexible working policy. Our employees also benefited from our parental leave programme, which is available to all full-time employees. In 2021, we had a 100% Return-to-Work rate for employees who took parental leave during the reporting period, with 10 female and 28 male employees taking maternity and paternity leave.

During the year, we also conducted initiatives geared towards improving the well-being and building the morale of our employees. Some of these include Volunteering programs, Friday Hangout with the CEO, Function Retreats and Team building exercises.

Following the 1999 Constitution of the Federal Republic of Nigeria, the Trade Union Act, and the Industry Procedural Agreement, all Lafarge Africa employees have the freedom of association and the right to join any union of their choosing.

Our staff members are affiliated with the following labour unions:

At Lafarge Africa, our workers have the right to openly express themselves and fully utilise their talents and abilities.

We constantly strive to improve our employees' job conditions, bolster their trust in the organisation, and maintain their motivation and engagement. This is achieved via our consistent engagement with our staff through surveys which vary in number yearly depending on specific concerns unique to each year.

Furthermore, we conduct focus group discussions with our employees in each department or business unit to ascertain their level of satisfaction with their current working conditions and to request their feedback on these conditions. As a result, we have been in a position to respond to the specific needs of our employees with targeted initiatives.

The HR team conducted talent conversations with employees. Some of the conversations were targeted at women in the industrial section. The feedback obtained from these sessions was applied in the resolution of internal concerns that had been brought to the attention of senior management. During the reporting period, we deployed four (4) pulse surveys to determine the level of employee satisfaction as it relates to well-being and work-life balance as well as their reception of new initiatives. One of the surveys deployed was designed to assess the response and adaptation of our employees to a group-wide initiative called THRIVE.

The results from the survey were used to improve the program. The progress of Project One, an initiative launched in 2020 to build a high-performing organisation, with one team moving in the same direction, was assessed in 2021.

The results of this survey highlighted areas that needed to be addressed as we continue to make progress towards ensuring a high-performing organisation.

With the work-from-home approach still fully in place in 2021, we made sure to keep our employees engaged while working remotely. The results of one of our employee engagement surveys showed that there was a need to focus on our engagements with our manufacturing plant-based population. In response to this, we began to tailor the CEO's hangout sessions to our plant population and leadership presence was increased as well.

In support of our women, we had a virtual celebration of International Women's Day in 2021. This was organised by the organisation's women in partnership with our communications team. We also launched the Green Women Network which serves as a platform where issues about women's wellbeing, career progression and related matters are promoted. The focus of the platform is women's inclusion.

During the reporting year, we also had a Career Week event during which we devoted a day to discuss issues surrounding gender and diversity and how to overcome prejudice. This day was dubbed 'Diversity Day'.

In delivering a quality learning system and environment in 2021, we maintained our knowledge transfer approach which is the 70:20:10 principle where 70% of knowledge transfer is derived on the job, 20% through coaching and mentoring and 10% from classroom training.

This ensures that all employees are afforded ample opportunity to put theoretical knowledge to work, on the job, while being accountable to coaches and mentors. We remain committed to finding new and engaging ways of bridging knowledge and experience gaps for our employees.

National Literacy Competition.

Our annual Lafarge Africa National Literacy Competition, which was established as a flagship Corporate Social Responsibility (CSR) effort by Lafarge Africa in 2014, has since evolved into a national program with a positive impact on children and teachers across the country.

The seventh edition of this competition was held in Nigeria in 2021, with the topic "Building the Nigeria of my dreams." The competition, which is accessible to students aged 9 to13 from public primary and secondary schools in the Junior and intermediate categories, is accepting submissions from December 4, 2020 through January 15, 2021.

One thousand six hundred (1600) contestants from all thirty-six states of Nigeria, as well as the Federal Capital Territory of Abuja, registered for the competition.

Miss Ewaade Adebowale of Alapere Primary School, Alapere-Lagos, who emerged as the overall winner in the Junior category, **received a cash prize of N1.5 million** in the Diamond category,

while Zainab Saliu of Ummul Khair Model School, Lagos and Emmanuel Somefun of Community Nursery & Primary School, Magodo-Lagos won **N1 million and N750,000 in the Gold and Silver categories** respectively. In addition, they won a number of intriguing educational consolation prizes.

In the Intermediate category, Miss Bilkisu Aliyu of U.B.E Junior Secondary School, Abaji, FCT was the overall winner and took home a cash prize of N1.5 million, while Ekpono Obot of Uyo High School, Uyo, Akwa Ibom and Alexandra Pearl Egonu of Federal Government Girls College, Nkwelle, Anambra State won N1 million and N750,000 in the Gold and Silver categories respectively.

This essay competition is evidence of the company's dedication to contributing to the development of the Nigerian kid through literacy, and strategic investments are being made across all levels of education in Nigeria.

Our goal is to leave a **legacy of quality education**, and the annual literacy competition is one of the efforts we take to equip our students for the future.









2021 Lafarge Africa National Literacy Competition

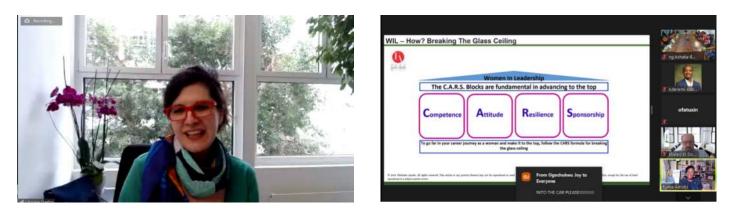


Diversity and Equality (SDGS 1,2,5,8,10,11)

Lafarge Africa's social investment projects impacted over 16,000 people in Ewekoro, with several initiatives addressing health and safety, education, rural electrification, infrastructure, and environmental sustainability implemented in multiple areas.

Among the initiatives are a 14-bed healthcare centre and medical equipment supplied to the Olujobi community, a 1.5-kilometer reinforced concrete road and drainage in Alagutan, a 4-kilometre pipe-borne water supply installed at Elebute, a transformer base for electrification at Okeoko Sekoni, and **several bursary awards given to students** from the communities currently enrolled in tertiary institutions in Nigeria.

Beyond the Ewekoro community, we made further investments in initiatives such as road construction at the Alaagutan Community, support towards the construction of a modern fire service station for Sagamu Community and provision of security personnel to improve the safety of the members of the Sagamu Community. In addition, we turned over a fully equipped COVID-19 isolation center in Ota, Ogun State, in 2021 which was funded in collaboration with Unilever Plc.

We joined the United Nations Children's Fund (UNICEF) six-point agenda in 2021, which calls for immediate global coordination to prevent the COVID-19 pandemic from becoming a child rights crisis.

The UNICEF six-point plan outlines a series of practical and specific steps to unite the international community around achieving the SDGs and the Convention on the Rights of the Child.

In this regard, one of our most significant CSR activities was the celebration of Children's Day at Ken-Ade Primary School, Makoko, a low-income school in the Lagos suburbs. To demonstrate how important education is to us, we provided learning aids such as notebooks, school bags, flasks, and a variety of books for their library in an effort to increase access to a high-quality education.

We also **pledged NGN 2 million for computer purchases and the construction of a school mini library.** Because some low-income students had dropped out, some students were awarded scholarships to rekindle their interest in pursuing a formal education.

Youth Empowerment (SDGS 1,2,4,8,9,11,16)

We are committed to being good corporate citizens, thus, we never lose sight of the importance of forming strong connections and collaborating closely with the local communities where our production facilities are situated.

As part of our effort to meet SDG 8 of promoting sustained, inclusive, and sustainable economic growth, full and productive employment, and decent work for all, we recognise that it is our responsibility as a company to contribute to the socioeconomic development of the communities in which we operate.

By making possibilities, such as employment training and skills acquisition programs, available to young people across a variety of our company's initiatives, we work in close partnership with the local communities to reduce the number of youths without jobs.

In collaboration with some of our partners, we also provided tricycles and motorbikes to community youth worth over NGN 16 million as part of our CSR initiatives, and we conducted a Country Education Program that included Career counselling and Waste to Wealth for low-income schools.

We also expanded our Skills Acquisition Scheme programme to include plumbing, auto-mechanic, carpentry, welding, red brick (production & laying),

fashion & tailoring, and beauty care in order to increase the pool of professionals in the country and provide them with a source of income.

Our training centres across our facilities have admitted and trained young secondary school graduates from the host communities into various programs. After graduation, some of these individuals were hired by Lafarge Africa, while others were hired by our third-party service providers. In addition, a number of the trainers are natives of the communities in which we operate.

During the reporting period, 30 apprentices were direct beneficiaries of these centres. 15 Cement Professionals Technicians Program (CPTP) Apprentices graduated, and 15 Technical Skills Development Program (TSDP) apprentices were recruited as well.

Sustainable Procurement and Supply Chain

At Lafarge Africa Plc, our sourcing processes are highly digital;

We have an e-sourcing platform that enables us to obtain additional information from our suppliers and contractors whenever necessary, and this platform has existed for some time. We also ensure that, prior to enrolling suppliers and contractors into our network, we obtain references from other organisations that have worked with the prospective supplier to confirm that they have a solid track record.

We at Lafarge Africa Plc adhere to relevant sustainable policies that will lower the environmental impact of our operations on the planet. In an effort to promote environmental sustainability and reduce our ecological footprint, we ceased using paper bags to wrap souvenirs and conference materials. We now utilise more eco-friendly, reusable, and recyclable bags. We also signed an agreement to the tune of adopting the use of LNG trucks for logistics purposes.

To manage the risks within our supply chain in 2021, we held several engagement sessions with our contractors and suppliers, taking steps to ensure that they were educated on our Supplier Code of Conduct and also, the new Code of Business Conduct that we embraced.

We also ensured that exposure was limited as regards buying supplies from the OECD listed pillar two countries. This was done via enlightenment programs that held with both our internal and external stakeholders in the supply chain. Intervention measures were also put in place and implemented when poor practices were observed during inspections across our plants.

Due to the competitive market in which we operate, in 2021, we focused our efforts on high market priority areas which are close to our plants, to defend our market shares. We also continued to drive very impactful channels across our supply chain.

We are committed to providing as much support to all members and key players within our value chain. To this effect, we employed different initiatives such as deploying field sales agents to support our distributors, giving away tricycles to members of communities surrounding our plants as rewards to facilitate our secondary distribution model, thus creating job opportunities in the process and improving the livelihoods of all beneficiaries.

This created a system of shared economic growth for both us and our suppliers and distributors. We also started a redistribution initiative where small 20 tonne trucks were distributed to our retailers across our market areas.

This was borne out of the concerns raised by retailers and dealers about the difficulties experienced by truck drivers in navigating the large trucks used in transporting our products across narrower streets, as well as the inability of some retailers to afford the cost of logistics.

The institute was established to promote professionalism and ensure that Heavy Goods Vehicles (HGV) are driven by trained professionals who have finished a program created exclusively for Nigerian truckers. The original objective of supporting safe, sustainable, and effective road transportation remains.

We understand the importance of forming strategic alliances with like-minded local and international parties as we use innovation to contribute to global efforts to address climate change and other issues in order to achieve a greener future.

We will continue to broaden our footprints as we seek opportunities to form new partnerships and strengthen existing ones.

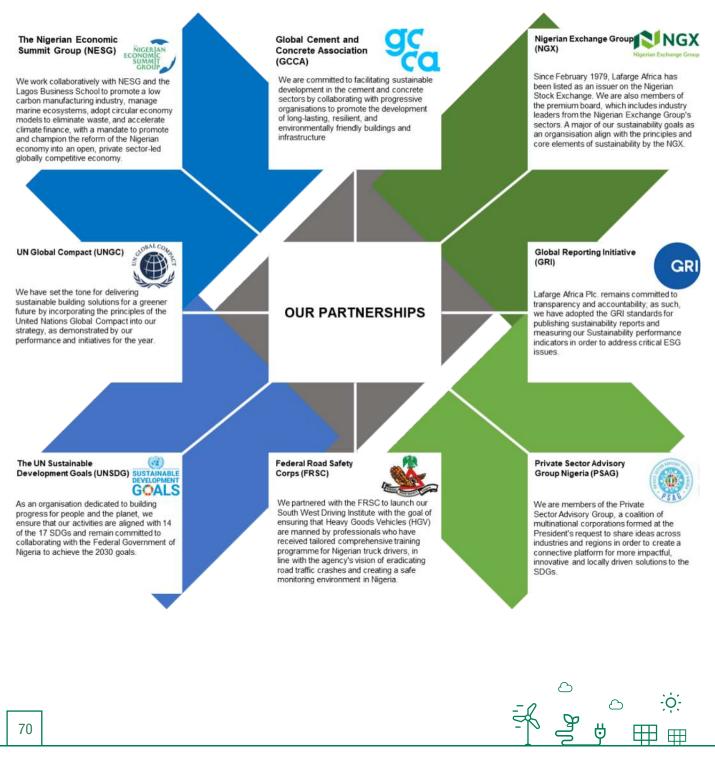

Inherent Limitations

Our Independence and Quality Control

We have complied with the independence and other ethical requirements of the International Ethics Standards Board for Accountants (IESBA) issued by the International Federation of Accountants, which is founded on the fundamental principles of integrity, objectivity, professional competence and due care, confidentiality and professional behaviour.

The firm applies the International Standard on Quality Control 1 (ISQC 1), and accordingly maintains a comprehensive system of quality control including documented policies and procedures regarding compliance with ethical requirements, professional standards and applicable legal and regulatory requirements.

Assurance provider's responsibility

Our responsibility is to express a conclusion on the sustainability report based on conducting a limited assurance engagement. We performed our limited assurance engagement in accordance with International Standard on Assurance Engagements (revised), Assurance Engagements Other Than Audits or Reviews of Historic Financial Information (ISAE 3000). This standard requires that we comply with ethical requirements and that we plan and perform the engagement to obtain limited assurance about whether the subject matter information is free from material misstatement.

Our assurance engagement involves performing procedures to obtain sufficient appropriate evidence about the sustainability report which is the subject of our assurance engagement. The procedures selected depend on our professional judgement, including an identification of areas where a material misstatement of the subject matter information is likely to arise whether due to fraud or error. In our identification, we considered internal control relevant to management's preparation of the sustainability report in order to design procedures that are appropriate in the circumstances.

A limited assurance is substantially less in scope than a reasonable assurance engagement in relation to both risk assessment procedures, including an understanding of internal control, and the procedures performed in response to the assessed risks. The procedures we performed were based on our professional judgement and included inquiries, observation of processes followed, inspection of documents, analytical procedures, evaluating the appropriateness of qualification methods and reporting policies, and agreeing or reconciling with underlying records.

Given the circumstances of the engagement, and performing the procedures listed above, we:

- Interviewed management to obtain an understanding of the internal control environment, risk
 assessment process and information systems relevant to the sustainability reporting process;
- Inspected documentation to corroborate the statements of management in our interviews;





- Tested the processes and systems to generate, collate, aggregate, monitor and report the selected sustainability information;
- Performed a controls walkthrough of identified key controls;
- Inspected supporting documentation on a sample basis and performed analytical procedures to evaluate the data generation and reporting processes against the reporting criteria;
- Evaluated the reasonableness and appropriateness of significant estimates and judgements made by Management in the preparation of the selected sustainability information; and
- Evaluated whether the selected sustainability information presented in the report are consistent with our overall knowledge and experience of sustainability management and performance at the Company.

The procedures performed in a limited assurance engagement vary in nature and timing and are less in extent than for a reasonable assurance engagement. As a result, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had we performed a reasonable assurance engagement. Accordingly, we do not express a reasonable assurance opinion about whether the Company's sustainability information have been prepared, in all material respects, in accordance with the accompanying Company's reporting criteria.

We believe that the evidence we have obtained is sufficient and appropriate to provide a basis for our conclusion.

Limited Assurance Conclusion

Based on procedures we have performed and the evidence we have obtained, and subject to inherent limitations outlined elsewhere in this report, nothing has come to our attention that causes us to believe that the selected sustainability information as set out in the subject matter paragraph above for the year ended 31 December 2021 are not prepared, in all material respects, in accordance with the reporting criteria.

Other Matters

The maintenance and integrity of Lafarge Africa's website is the responsibility of Lafarge Africa PLC's Directors. Our procedures did not involve consideration of these matters and, accordingly we accept no responsibility for any changes to either the information in the Report or our independent assurance report that may have occurred since the initial date of presentation on Lafarge Africa PLC's website.

Our work has been undertaken to enable us to express a limited assurance conclusion on the selected sustainability information to the Directors of the Company in accordance with the terms of our engagement, and for no other purpose.
