FINANCIAL HIGHLIGHTS

REVENUE

During the year, cement demand witnessed a progressive decline in growth due to the recession in Nigeria, while market in South Africa remained soft. The combination of the softening of the cement market and operational issues in the first part of the year namely gas shortages, logistics issue and technical stoppages have affected our revenue against corresponding period last year. However, revenue for Q4 increased by 12% on the basis of the operational turn around plan.

PROFIT AND NET INCOME

Profit for the Group was affected by lower sales and the operational challenges the company faced during the first 9 months. However the turnaround plan delivered strong performance during the last Quarter to restore profitability.

The debt restructuring has been fully completed at year end with the conversion of the debt as equity instrument and the prepayment of the syndicated loan. A deferred tax asset of N40bn has been recognized in Unicem.

Lafarge Africa Plc is ending the year with a Profit after Tax of N16.9bn and proposed a dividend of 105kobo per share.
