PROPOSED SCHEME OF ARRANGEMENT FOR THE REORGANISATION OF CAPITAL BETWEEN ASHAKACEM PLC AND THE HOLDERS OF ITS FULLY PAID ORDINARY SHARES OF 50 KOBO EACH

Introduction

Lafarge Africa acquired 1,312,444,260 shares, being 58.61% of Ashaka Cement Plc ("AshakaCem"), from Lafarge SA in October 2014. This acquisition triggered a Mandatory Tender Offer ("MTO") under the provisions of Section 131(1)(a) of the ISA, which was made by Lafarge Africa in December 2014. At the conclusion of the MTO, Lafarge Africa acquired an additional 534,144,592 shares of AshakaCem thus increasing its equity stake to 82.46% leaving minority shareholders holding 17.54%.

At the conclusion of the MTO, a number of shareholders who were unable to participate in the MTO given logistics and other difficulties experienced at the time sought another opportunity to participate in a tender of their shares. A Voluntary Tender Offer ("VTO") to minority shareholders was therefore made by Lafarge Africa in May 2016. The VTO was concluded in July 2016 and a further 56,161,661 shares were tendered thus increasing Lafarge Africa's shareholding to 84.97%. Minority shareholders held 15.03% of the issued share capital.

Following the MTO and VTO transactions, AshakaCem's Free Float stood at 15.03%, significantly below the NSE's minimum Free Float of 20.00%. The Company took the view that it was probable that the NSE could take enforcement action given the Free Float deficiency and initiate a Regulatory Delisting as the Free Float deficiency was not likely to be remedied.

Thus, in December 2016, on the recommendation of the Directors of AshakaCem, the shareholders of the Company passed a resolution approving the Voluntary Delisting of AshakaCem. As part of the Voluntary Delisting process, the Company provided a path for minority shareholders who did not wish to remain in the unlisted company to exit the Company. At the completion of the process, eight hundred and ninety-one (891) shareholders accepted the exit consideration and ceased to be members of AshakaCem.

At the expiration of the statutory ninety (90) day notice period stipulated by the Exchange on March 17, 2017 - and further to the 891 shareholders acceptance of the exit consideration offered by AshakaCem - Lafarge Africa's holding in AshakaCem increased to 86.51%.

The NSE subsequently confirmed the delisting of AshakaCem on July 4, 2017. Consequently, the Company is no longer listed on the Daily Official List. The Company's shares are no longer traded on the Exchange; and the shares

are in the process of being expunged from the CSCS depository. As a condition of the delisting of the Company's shares, the Quotations Committee of The Nigerian Stock Exchange has also stipulated that AshakaCem pay ¥15.74 per share to shareholders that opt to exit the Company.

The Scheme

Following the delisting of AshakaCem, the ability of the Shareholders to liquidate their shareholding has, accordingly, been further curtailed. The Company has also - subsequent to the delisting - received enquiries from shareholders seeking information on whether the exit option previously offered (of Lafarge Africa shares and cash) may be made available to them on the same terms.

The Board of Directors are also of the view that it is highly unlikely that the Company will be successful in raising, through an equity transaction, the significant additional capital required over the next two to three years to meet AshakaCem's expansion plans and maintain the Company's competitive advantage in the cement manufacturing space, particularly given the dislocations in the finance sector. Furthermore, and in light of the Company's ambitious expansion plans, the Company intends to re-invest and utilize any cash generated from existing assets to partly fund its expansion plans, thus restricting its ability to pay dividends to shareholders in the short to medium term.

Therefore, the Board of Directors has, after very careful consideration of the Company's current corporate structure, the expansion plans and the funding requirements for the Company's business; formed the view that a Scheme of Arrangement reorganising the shareholding structure of the Company is in the best interest of both the Company and its shareholders. The Scheme will principally enable the shareholders to, once again, hold shares which are listed and tradeable. The Scheme is supported by Lafarge Africa, the majority shareholder of the Company.

In light of the foregoing, the Board of Directors has resolved to recommend the proposed Scheme of Arrangement for the consideration of the Company's shareholders at the meeting to be convened by an order of the Federal High Court.

Basis of the Scheme Consideration

The Scheme of Arrangement is summarised below:

The terms and effects of the Scheme are explained further in an Explanatory Statement from the Financial Advisers to AshakaCem on Pages 13 to 18 of this document.

The Company has neither sought, nor obtained an undertaking to vote or procure votes (either in part or in whole) in favour of the Scheme.

The Lafarge Africa shares which constitute the Share Consideration have been registered with the SEC. Furthermore, Lafarge Africa has confirmed that it has sufficient unissued shares in its Authorised Share Capital for the settlement of the share consideration.

Lafarge Africa has sufficient funds to settle the Total Cash Consideration of N604,091,586 as evident by its cash balance of N25 billion as at June 30, 2017 as contained in its Half Yearly Financial Statements for the period ended June 30, 2017.

Effects of the Scheme

The successful completion of the Scheme will result in AshakaCem being wholly owned by Lafarge Africa and/or its nominee(s). The table below illustrates the Post Scheme shareholding structure of the Company, following the proposed scheme for the reorganisation of AshakaCem's capital:

Settlement and Financing of the Scheme Consideration Recommendation

The Board of Directors of AshakaCem Plc, as advised by Chapel Hill, considers the terms of the Scheme to be fair and are recommending the Scheme for the following reasons:

- 1. The proposed Scheme Consideration represents a total value of №19.78 per AshakaCem share, a 26% premium to the №15.74 consideration stipulated by The NSE and a 16% premium to the last traded share price of the Company of №17.08.
- 2. Furthermore, the Share Consideration, the Lafarge Africa shares, offers the Shareholders a continuing opportunity for capital appreciation through the issuance of future bonus shares and dividend¹.
- 3. The Scheme will offer the Holders revenue diversification by geography given Lafarge Africa's operations in Nigeria, South Africa and Ghana; and revenue diversification by plant location due to operations in the North East (which have been hampered by disruptions due to insurgency), South East and South West regions of Nigeria, both of which have witnessed continued and uninterrupted operations for a number of years.
- 4. The Scheme will enable the Holders to, once again, hold listed and tradable securities (Lafarge Africa shares) and provide an opportunity to the Holders to monetize their investment should they desire to do so.
- 5. The implementation of the Scheme will ease the speed and the cost at which AshakaCem can attract capital to fund its expansion plans.

PROPOSED SCHEME OF ARRANGEMENT FOR THE REORGANISATION OF CAPITAL BETWEEN ASHAKACEM PLC AND THE HOLDERS OF ITS FULLY PAID ORDINARY SHARES OF 50 KOBO EACH

5.1 Introduction

You have been informed by the letter from your Chairman, presented on pages 9 to 12 of this document, of the proposal to reorganise the share capital of the Company. The reorganisation of capital will be effected by a Scheme of Arrangement pursuant to Section 539 of the Companies and Allied Matters Act Cap C20 LFN 2004.

Your Directors have authorised us, as Financial Adviser to the Company, to write to you on their behalf, to explain the terms, conditions, provisions and effects of the Scheme as well as provide other relevant information as summarised below:

5.2 The Transaction

The Proposal is for the reorganisation of AshakaCem's capital which is to be effected through the Scheme.

Share Capital Reorganisation

The Company's issued and fully paid up share capital is \$\frac{\text{N1}}{119,726,563}\$ (One Billion, One Hundred and Nineteen Million, Seven Hundred and Twenty-Six Thousand, Five Hundred and Sixty-Three Naira) comprising 2,239,453,125 (Two Billion Two Hundred and Thirty-Nine Million, Four Hundred and Fifty-Three Thousand, One Hundred and Twenty-Five) ordinary shares of 50 Kobo each. Lafarge Africa currently holds 1,937,407,332 ordinary shares with the remaining Scheme Shares (302,045,793 Ordinary Shares) held by 62,546 (Sixty Two Thousand, Five Hundred and Forty Six) shareholders. To effect the Transaction, it is proposed that:

i. Pursuant to Section 539 of CAMA, the Scheme Shares held by the Holders shall be exchanged for the Scheme Consideration.

Following the exchange, the Company will be re-registered as a private limited liability company pursuant to the relevant provisions of CAMA.

5.3 Conditions Precedent

The Transaction is subject to the fulfilment of the conditions precedent detailed below:

- Approval of the Scheme of Arrangement by a majority of the Shareholders, representing not less than three-quarters (3/4) in value of the Company's Shares held by those present and voting, either in person or by proxy at the Court-Ordered Meeting
- ✓ The Scheme of Arrangement being sanctioned with or without modification by the Court
- ✓ The delivery of the certified true copy of the Court Sanction to the CAC for registration Once sanctioned by the Court, the Scheme of Arrangement will be binding on all the Shareholders of the Company including those who did not attend the Meeting, or those who attended the Meeting and did not vote or who voted against the Scheme of Arrangement at the Meeting. On the Effective Date any share certificates representing the interests of the Holders in the Scheme Shares shall cease to be valid. Furthermore, Scheme Shares previously held in dematerialized form shall also be invalid, such shares having been expunged from the records of the CSCS following the delisting of the Company. In respect of the Scheme Shares, the information on the Register at the Qualification Date (and as confirmed by any information provided by the CSCS as at the Qualification Date) shall be the definitive proof of shareholding.

5.4 Meeting to Approve the Scheme of Arrangement and Voting Rights

The Court-Ordered Meeting - which has been scheduled to hold on Monday, October 23, 2017 at Sheraton Hotel, 1 Ladi Kwali Way, Wuse Zone 4, Abuja at 10:00am - is being held at the direction of the Court for the purpose of considering and if thought fit approving the Scheme of Arrangement. At the Court-Ordered Meeting, each Shareholder entitled to vote will be entitled to one vote for every Ordinary Share held. Voting at the Court-Ordered Meeting will be by poll (and not a show of hands). The statutory majority required at the meeting is a majority representing not less than three-quarters in value of the Ordinary Shares of members present and voting in person or by proxy.

Lafarge Africa, the majority shareholder in AshakaCem, has informed AshakaCem that it has decided not to exercise its right of voting at the Court-Ordered Meeting. Thus, Lafarge Africa will not be voting at the Court-Ordered Meeting.

So far as the Company and the Financial Adviser are aware, no undertaking to vote has been secured, nor has any vote been procured in favour of the resolution to approve the Scheme.

5.5 Basis of Scheme Consideration

As consideration for the exchange of the Scheme Shares, each Holder of the Scheme Shares shall receive:

- Share Consideration: 57 Lafarge Africa shares for every 202 AshakaCem shares held as at the Effective Date; and
- Cash Consideration: N2 per share
- a. Share Consideration

The share consideration is based on the same terms agreed between Lafarge Africa Plc and AshakaCem on the date that Lafarge Africa's 58.61% acquisition of AshakaCem was announced. This represents a 16% premium to the AshakaCem last trading day price of №17.08 on June 3, 2017, and a 26% premium to the consideration of №15.74 stipulated by The NSE.

b. *Cash Consideration*

The sum of N2.00 (Two Naira) per share, net of any applicable tax for each AshakaCem share acquired was strongly recommended to the Board of Lafarge Africa by the Board of AshakaCem, and having been accepted by Lafarge Africa represents an upgrade to the terms under which Lafarge Africa had previously acquired 58.61% of the issued share capital of AshakaCem from Lafarge Nigeria (UK) Limited.

The Scheme Consideration represents a 16% premium to the AshakaCem last trading day price of ¥17.08 on June 3, 2017, and a 26% premium to the consideration of ¥15.74 stipulated by The NSE.

The consideration stipulated were also offered in the previous MTO and VTO transactions and represents an opportunity for the minority shareholders to share in the fortunes of the growth platform which Lafarge Africa presents.

The Lafarge Africa shares which constitute the Share Consideration have been registered with the SEC. Furthermore, Lafarge Africa has confirmed that it has sufficient unissued shares in its Authorised Share Capital for the settlement of the share consideration.

Lafarge Africa has sufficient funds to settle the Total Cash Consideration of N604,091,586 as evident by its cash balance of N25 billion as at June 30, 2017 as contained in its Half Yearly Financial Statements for the period ended June 30, 2017.

5.6 Settlement of Scheme Consideration

a. Share Consideration

Following the approval of the Scheme at the Court-Ordered Meeting, Lafarge Africa will ensure that the company's Registrar effects the allotment of the Share Consideration to each of the Holders. Allotment of the Share Consideration to the Holders shall be conducted by Lafarge Africa's Registrar in accordance with its regular allotment procedures and as required by applicable law and rules and regulations of the SEC. In this regard, Holders that do not already have one may be required to open CSCS accounts and the Lafarge Africa shares allotted to such Holders will be credited at the CSCS using a Registrar Identification Number ('RIN'). number, is advised to open a stockbroking account with a stockbroker and obtain a valid CHN and CSCS account number from the stockbroker.

b. Cash Consideration

AshakaCem will enter into an account agreement with the Account Bank and open the Scheme Consideration Account. Within 14 (fourteen) Business Days of the Effective Date, Lafarge Africa shall fund the Scheme Consideration Account with the Total Cash Consideration.

The Cash Consideration to which each Holder shall become entitled shall be transferred to the Registrar, for onward settlement, by way of warrants. The Cash Consideration will be remitted to each Holder by the Registrars within 28 (twenty-eight) Business Days of the Effective Date.

c. Plans for Untraceable Holders

With respect to the Share Consideration, the CSCS shall be responsible for warehousing the Share Consideration on behalf of untraceable Holders and such shares shall be held in trust for untraceable Holders for a period of 12 (twelve) years from the Effective Date. At the expiration of this period, any unclaimed shares shall be deemed surrendered to Lafarge Africa.

The Cash Consideration to which each Holder shall become entitled pursuant to the Scheme shall be held in trust for the benefit of all Holders for a period of 12 (twelve) years from the Effective Date (the "Final Payment Date").

On the Final Payment Date, the entitlement of any Holder of Scheme Shares to any Cash Consideration remaining unclaimed shall be extinguished and any portion of the Cash Consideration remaining unclaimed on the Final Payment Date shall revert to Lafarge Africa.

d. Plans for Holders of Scheme Shares Subject to Encumbrance

Payment of the Scheme Consideration to Holders whose shares have been charged as collateral or which are subject to a lien or other encumbrances may be withheld by the Registrar, pending satisfactory resolution of the underlying indebtedness.

5.7 Provision for Dissenting Shareholders

There are no specific arrangements for shareholders who vote against the Scheme. All shareholders of the Company will be entitled to the Scheme Consideration, *pro rata* to their respective shareholding in the Company. Under the provisions of Section 539 of CAMA, the Scheme binds the Shareholders and the Company where the statutory majority of shareholders votes in favour of the Scheme.

The lodging of a proxy form, which, to be valid must be appropriately stamped, does not prevent you from attending the relevant meeting and voting in person should you so wish. However, in such instance, your proxy will not be entitled to attend or vote.

b. Delivery and Settlement

As of the Effective Date of the Scheme, all existing share certificates and CSCS account balances for all the Holders in relation to the Scheme Shares will be delivered to the Registrar or the Company. Lafarge Africa will issue and allot to each of the Holders, the Share Consideration via an e-allotment. In accordance with the SEC Directive on Dematerialization of Share Certificates, shareholders who do not provide valid CHN and CSCS account numbers will have their shares credited at the CSCS using a Registrar Identification Number. A Registrars Identification Number is a number allocated to shareholders who do not have valid CHN and CSCS account numbers to warehouse their units of shareholding in public companies under Registrars custody at the CSCS. 5.9 Related Party

5.10Taxation

Under current Nigerian tax legislation, the implementation of the Scheme of Arrangement as proposed will not give rise to any taxation disadvantages to the minority shareholders, either with respect to capital gains tax or stamp duty. However, this statement is not intended to be, and should not be construed to be, legal or tax advice.

Shareholders who are in any doubt about their taxation position, or who are subject to taxation in a jurisdiction outside Nigeria, are strongly advised to consult their professional advisers without delay as to the consequences of the Scheme in view of their circumstances.

5.11 Background on Lafarge Africa

Lafarge Africa Plc. (formerly known as Lafarge Cement WAPCO Nigeria Plc.) ("Lafarge Africa" or "the Company") was incorporated on February 24, 1959. The company emerged from the asset consolidation – in June 2014 – of Lafarge S.A.'s Nigerian and South African assets, namely Lafarge South Africa Holdings (Proprietary) Limited ("LSAH"), United Cement Company of Nigeria Limited ("Unicem"), Ashaka Cement Plc ("Ashaka Cement") and Atlas Cement Company Limited ("Atlas Cement"). The asset consolidation of Lafarge Africa Plc has grown the cement capacity of the firm from c.4.5MTpa to c.14 million metric tonnes per annum (mtpa). Moreover, the firm's range of products is more diversified with additional production in Ready-Mix, Fly Ash and aggregates.

The Company's primary business activity is the manufacturing and marketing of cement products and providing business solutions. Lafarge is one of the market leaders in the Nigerian cement industry with its core brand, Elephant Cement, continuing to assert itself as a superior product. Elephant Cement has consistently

Lafarge Africa has an increased range of product and services, positioning it strongly to meet the growing and changing demand for building materials in Sub Saharan Africa including installed cement production capacity of 14 mtpa, aggregates 5mtpa, Ready-Mix concrete 3.5 million cubic meter and a market leading position in pulverized fly ash. The Company's brands include Elephant Cement, Supaset Cement, Powermax, Sulphate Resisting Cement and Readymix.

A. PRELIMINARY

In this Scheme, as hereinafter defined, the following expressions have the following meanings where the context so admits:

Allotment of the Share Consideration to the Holders shall be conducted by Lafarge Africa's Registrar in accordance with its regular allotment procedures and as required by law and the applicable rules and regulations of the SEC. In this regard, Holders that do not already have one may be required to open CSCS accounts and the Lafarge Africa shares allotted to such Holders will be credited at the CSCS using a Registrar Identification Number ('RIN'). A Registrars Identification Number is a number allocated to shareholders who do not have valid CHN and CSCS account numbers to warehouse their units of shareholding in public companies under Registrars custody at the CSCS. The allotted shares will be transferred to the stockbroking account of the shareholder once valid CHN and CSCS account numbers are provided. Any shareholder who does not have a valid CHN and CSCS account number, is advised to open a stockbroking account with a stockbroker and obtain a valid CHN and CSCS account number from the stockbroker.
- 4.2 Lafarge Africa shall fund the Scheme Consideration Account with the Total Cash Consideration within 14 (fourteen) Business Days of the Effective Date. The Cash Consideration to which each Holder shall become entitled shall be transferred to the Registrar, for onward settlement of the Holders and may be remitted by way of electronic transfer to each Holder by the Registrars in accordance with the applicable SEC rules and regulations within 28 (twenty-eight) Business Days of the Effective Date.
- 4.3 Notwithstanding the provisions of Clause 4.2, the Holders who have registered for the electronic payment system (e-dividend) with the Registrars will receive a direct credit of the amounts due to them in respect of the Cash Consideration to their registered account in their respective nominated banks.
- 4.4 Payment of the Cash Consideration due in respect of the Scheme Shares shall be made in Nigerian Naira through e-payments made to the Scheme Shareholders. Receipt of the credit into the account provided by a Holder shall be a complete discharge to the Company and Lafarge Africa for the Cash Consideration represented thereby. CONDITIONS PRECEDENT

- As from the Effective Date, the Scheme shall become binding on all shareholders of the Company irrespective of whether or not they attended or voted at the Court-Ordered Meeting (and if they attended and voted, irrespective of whether or not they voted in favour of the Scheme), if:
 - 6.1 The Scheme is approved by a majority representing three-fourths in value of the holders of the shares of the Company present and voting either in person or by proxy at the Scheme Meeting;

In the case of the death of a member, the survivor where the deceased was a joint holder, and the legal personal representatives of the deceased where he was a sole holder, shall be the only person recognised by the company as having any title to his interest in the shares, but noting herein contained shall release the estate of a deceased joint holder from any liability in respect of any share which had been held joint by him with other persons.

Person becoming entitled on death or bankruptcy of a member may be registered

31. Any person becoming entitled to a share in consequence of the death or bankruptcy of a member may, upon such evidence being produced as may from time to time properly required by the Directors and subject as hereinafter provided elect either to be registered himself as holder of the share or to have some person nominated by him registered as a transferee thereof, but the Directors shall, in either case have the same right to decline or suspend registration as they would have had in the case of a transfer of the share by that member before his death or bankruptcy, as the case may be.

Person electing to be registered to give notice

32. If the person so becoming entitled shall elect to be registered himself, he shall deliver or send to the Company a notice in writing signed by him stating that he so elects. If he shall elect to have another person registered he shall

testify his election by executing to that person a transfer of the share. All the limitations, restrictions and provisions of these Article relating to the right to transfer and the registration of transfer of share shall be applicable to any such notice or transfer as aforesaid as if the death bankruptcy of the member had not occurred and the notice or transfer were a transfer signed by the member.

As a right of person entitled by transmission received dividends

33. A person becoming entitled to a share by the reason of the death or bankruptcy of the holder shall be entitled to the same dividends and other advantages to which he would be entitled if he were the registered holder of the share, except that he shall not, before being registered as a member in respect of the share be entitled in respect of it to exercise any right conferred by membership in relation to meetings of the company. Provided that the directors may at any time give notice requiring any such person to elect either to be registered himself or to transfer the share, and the Directors may thereafter withhold payment of all dividends, bonuses or other money payable in respect of the share until the requirements of the notices have been complied with.

Notice of unpaid call

34. If a member fail to pay any call or instalment of a call on the day appointed for payment thereof, the Directors may, at any time thereafter during such time as any part of the call or instalment remains unpaid, serve a notice on him requiring payment of so much of the call or instalment as is unpaid, together with any interest which may have accrued.

Notice to contain certain particulars

35. The notice shall name a further day (not earlier than the expiration of fourteen days from the date of service of the notice) on or before which the payment required by the notice is to be made, and shall state that in the event of non-payment at or before the time appointed the shares in respect of which the call was made will be liable to be forfeited.

Forfeiture of non-compliance with notice

36. If the requirements of any such notice as aforesaid are not complied with, any share in respect of which the notice has been given may at any time thereafter, before the payment required by the notice has been made, be forfeited by a resolution of the Directors to effect.

Disposal of forfeited shares

37. A forfeited share may be sold or otherwise disposed of on such terms and in such manner as the Directors think fit, and at any time before a sale or disposition the forfeiture may be cancelled on such terms as the Directors think fit.

Holders of forfeited shares liable for unpaid calls

38. A person whose shares have been forfeited shall cease to be member. In respect of the forfeited shares, but shall notwithstanding, remain liable to pay to the Company all money which, at the date of forfeiture, were payable by him to the company in respect of the share, but his liability shall cease if and when the company shall have received payment in full of all such money in respect of the shares.

Titles to forfeited shares

39. A declaration in writing that the declarant is a Director of the Company, and that the share in the Company has been forfeited on a date stated in the declaration, shall be conclusive evidence of the facts therein stated as against all persons claiming to be entitled to the share. The company may receive to be entitled to the share. The company may receive the consideration, any, given for the share on any sale or disposition thereof and may execute a transfer for the share in favour of the person to whom the share is sold or disposed of, and he shall thereupon be registered as the holder of the share, and shall not be bound to see the application of the purchase money, if any, nor shall his title to the share be affected by any irregularity or invalidity in the proceedings in reference to the forfeiture, sale or disposal of the share.

Forfeiture in respect of sums other than call

40. The provisions of these Articles as to forfeiture shall appl in the case of non-payment of ay sum which, by the terms of issue of a share, becomes payable at a fixed time whether on account of the nominal value of the share or by way of premium, as if the same had been payable by virtue of all call duly made and notified.

ALTERATION OF CAPITAL

Increase of share capital

45. The company may from time to time, whether all the share for the time being authorised shall have been issued or all the shares for the time being issued shall have been fully called up or not, by special resolution increase the shares capital by such sum to be divided into share of such amount as the resolution shall prescribe.

Reorganisation

The Company may by special resolution:

- 46. (a) Consolidate and divide all or any of its share capital into shares, of larger amount than its existing shares.
- (b) Sub-divide its existing shares, or any of them into shares of smaller amount than is fixed by the Memorandum of Association subject nevertheless to provisions of section 100 (1) (c) of the Acts; and
- (c) Cancel any shares, which, at the date of the passing of the resolution, have not been taken or greed to be taken by any person.

Reduction of capital

47. The company may by special resolution reduce its share capital, any capital redemption reserve fund or any share premium account in any manner and with, and subject to, any incident authorised and consent required by law.

GENERAL MEETINGS

Annual General

48. The Company shall in each calendar year hold a general meeting as its Annual general meeting in addition to any other meetings in that year, and shall specify the meeting as such in the notice calling it; and not more than fifteen months shall elapse between the date of one Annual General meeting shall be held in Nigeria at such time and place as the Directors shall appoint.

Extraordinary General Meetings

49. All general meetings other than Annual General Meetings shall be called Extraordinary General Meetings, and all such meetings shall be held in Nigeria.

How meetings convened

50. The Directors may whenever they thing fit, convene an Extraordinary General Meeting, and Extraordinary General Meetings shall also be convened on such requisition's, as provided by section 215 of the Acts. If at any time there are not available sufficient directors capable of acting to form a quorum, any director or any two members of the company may convened by the directors.

Notice of Meetings

51. An annual general Meeting and a meeting called for the passing of a special resolution shall be called by twenty-one days' notice in writing at the least and a meeting of the company other than an Annual General Meeting or a meeting for the passing of a special resolution shall be called by fourteen days' notice in writing at least. The notice shall be exclusive of the day on which it is served or deemed to be served and of the day for which it is given and shall specify the place the day and the hour or meeting and, in case of special business, the general nature of that business, and shall be given, in a manner hereinafter mentioned or in such other manner, if any, as may be prescribed by the company in general meeting to such persons as are under the regulations of the company, entitled to receive such notices form the company.

Short Notice

52. Provided that a meeting of the company shall notwithstanding that it is called by shorter notice than that specified in this Article, be deemed to have been duly called it is so agree:

- (a) In the case of a meeting called as the Annual General Meeting, by all the members entitled to attend and vote thereat; and
- (b) In the case of any other meeting, by a majority together holding not less than 95 per cent in nominal value of the shares giving that right.

Effect of omission

- 52. The accidental omission to give notice of a meeting to, or the non-receipt of notice of a meeting by, any person entitled to receive notice shall not invalidate the proceedings at that meeting.
- 53. All business shall be deemed special that is transacted at an Extraordinary General Meeting, and also all that is transacted at an Annual General meeting with the exception of declaring a dividend, the consideration of the accounts balance sheets and the reports of the Directors and auditors, the election of Directors in the place of those retiring and the appointment of, and the fixing of the remuneration of the auditors.

Quorum

54. Save as herein otherwise provided, three members present in person or by proxy shall be a quorum and no business shall be present at the time when the meeting proceeds to business.

If no quorum

55. If within half an hour from the time appointed for the meeting a quorum is not formed, the meeting, if convened upon requisition of members, shall be dissolved; in any other case it shall stand adjourned to the same day in the next week at the same time place as the Director may determine, and if at the adjourned meeting a quorum is not formed within half an hour from the time appointed for the meeting, the members present shall be a quorum.

Chairman of meeting

56. The Chairman, if any, of the Board or Director shall preside as at Every general meeting of the company, or if there is not chairman, or if he shall not be present within fifteen minutes after the time appointed for the holding of the meeting or is unwilling to act the Directors present shall elect one their number to be chairman of the meeting.

57. If at any meeting no director is willing to act as Chairman or if no director is present within fifteen minutes after the time appointed for holding the meeting, the members present shall choose one of their to be Chairman of the meeting.

Adjournment of Meetings

58. The Chairman may, with the consent of any meeting at which a quorum is present (and shall if so directed by the meeting), adjourn the meeting from time to time and place to place, but no business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place. When a meeting is adjourned for thirty days or more, notice of the adjourned meeting shall be given as in the case of an original meeting. Save as aforesaid it shall not be necessary to give any notice of an adjournment or of the business to be transacted at an adjourned meeting.

How resolution

59. At any general meeting a resolution to the vote of the meeting shall be decided on a show of hands unless a poll is demanded:

- (a) By the chairman; or
- (b) By at least three member present in person or by proxy' or;

- (c) By any member or members present in person or by proxy and representing not less than one-tenth of the total voting rights of all the members having the right to vote at the meeting' or
- (d) By a member or members holding shares in the company conferring a right to vote at which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the shares conferring the right.

Unless a poll be so demanded a declaration by the Chairman, that a resolution has on a show of hand been carried or carried unanimously, or by a particular majority, or lost, and an entry to that effect in the book containing the minutes of the proceedings of the company shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against such resolution.

The demand for a poll may be withdraw before or on the declaration of the result of the show of hands.

How poll taken

60. Except as provided in Article 64 if a poll is dully demanded it shall be taken in such manner as the chairman directs, and the result of the poll shall be deemed to be the resolution of the meeting at which the poll was demanded.

Chairman to have

61. In the case of an equality of votes, whether on a show of hands or on a poll, the chairman of the meeting at which the show of hands takes place or at which the poll is demanded, shall be entitled to be a second or casting vote.

Other business may proceed despite demand for poll

62. A poll demanded on the election of a chairman or on a question of an adjournment shall be taken forthwith. A poll demanded on any other question shall be taken at such time as the Chairman of the meeting directs, and any business other than upon which a poll had been demanded may be proceeded with pending the taking of the poll.

VOTE OF MEMBERS

Right of voting

63. Subject to any right or restrictions for the time being attached to any class or classes of shares, on a show of hands every member present in person or by proxy shall have one vote of each share of which he is the holder.

Joint holders

64. In the case of joint holder the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the purpose seniority shall be determined by the order in which the names stand in the register of members.

Lunatic members

65. A member of unsound mind, or in respect of whom an order has been made by any court having jurisdiction in lunacy, may vote, whether on a show of hands or on a poll, by his committee, receiver, curator bonus, or other person may, on a poll, vote by proxy.

No right to vote unless all calls paid

66. No member shall be entitled to vote at any general meeting unless all calls or other sums presently payable by him in respect of shares in the company have been paid.

Objections to

67. No objection shall be raided to the qualification of any voter except at the meeting or adjourned meeting at which the vote not disallowed at given or tendered, and every vote not disallowed at such meeting shall be valid for all purchase. Any such object made in due time shall be referred to the Chairman of the meeting, whose decision shall be final sand conclusive.

Proxy vote

68. On a poll votes may be given either personally or by proxy.

Instrument of proxy to be in writing

69. The instrument appointing a proxy shall be in writing under the hand of the appointer or of his attorney dully authorised in writing, or, if the appointer is a corporation, either under seal, or under the hand of an officer or attorney dully authorised. A proxy need not be a member of the company.

And to be deposited at the office

70. The instrument appointed a proxy and the power of attorney or other authority, if any, under which it is signed or a notarially certified copy of that power or authority shall be deposited at the office or at such other place within Nigeria as may be specified for that purpose in the notice convening the meeting, not less than 24 hours before the time for holding the meeting or adjourned meeting, at which the person named in the instrument proposes to vote, or into the case of a poll, not less than 24 hours before the time appointed for taking to the pool, and in default the instrument of proxy shall not be treated as valid.

Proxy may demand a poll

73. The instrument appointing a proxy shall be deemed to confer authority to demand or join in demanding a poll.

When proxy valid though authority revoked

74. A vote given in accordance with term of an instrument of proxy shall be valied notwithstanding the previous death or insanity of the principal or revocation of the proxy or of the authority under which the proxy was executed, or the transfer of the share in respect of which the proxy is given, provided no intimation in writing or such death, insanity, revocation or transfer as aforesaid shall have received by the company at the office before the commencement of the meeting or adjourned meeting at which the proxy is used.

8.2 CLAIMS AND LITIGATION

- 1. As of Effective Date, the Company was involved in 3 (three) cases. Out of the 3 (three) cases:
 - a. 3 (Three) cases are pending before the Supreme Court; and
 - b. none of the cases was instituted by or at the instance of the Company; rather all the cases were initiated against the Company as defendant.
- 2. The aggregate amount claimed against the Company in all the cases pending against it (both at the court of first instance and on appeal) is ¥181,201,317.37 (One Hundred and Eighty-One Million, Two Hundred and One Thousand, Three Hundred and Seventeen Naira and Thirty-Seven Kobo).
- 3. The Directors of the Company are of the opinion that the aforementioned cases are not likely to have any material adverse effect on the Company or the proposed Scheme of Arrangement and are not aware of any other pending and/or threatened claims or litigation which may have material effect on the Scheme of Arrangement.

8.3 MATERIAL CONTRACTS

- 1. A Mandate Letter issued by AshakaCem Plc appointing Chapel Hill as Financial Adviser; and
- 2. A Financial Advisory Services Agreement between AshakaCem Plc and Chapel Hill which sets out the terms and conditions under which Chapel Hill Advisory Partners Limited has agreed to act as Financial Adviser to AshakaCem Plc in respect of the Scheme.

Other than as stated above, AshakaCem has not entered into any material contract except in the ordinary course of business.
